# CHALLENGE OVERVIEW

## Purpose and Call to Action

The purpose of the CTE CHIPS Challenge<sup>ii</sup> is to expand student recruitment, training, and placement strategies in semiconductor fabrication (fab) construction and advanced manufacturing careers that align with the CHIPS and Science Act ([CHIPS](#)). The U.S. Department of Education (Department) invites entrants to submit innovative action plans to: (a) increase students' opportunities to develop skills and experiences that better prepare them for the careers aligned with [CHIPS](#); (b) expand student recruitment, training, and placement strategies in these careers; and (c) support teachers in building out CTE programs.

## Challenge Eligibility

An eligible entrant to the CTE CHIPS Challenge must satisfy the requirements of either (1) or (2):

- (1) An eligible recipient under [section 3\(21\) of Perkins V \[20 U.S.C. 2302\]](#). The term eligible recipient means:
  - (A) a ["local educational agency" \[20 U.S.C. 8101\(30\)\]](#) (including a public charter school that operates as a local educational agency), an ["area career and technical education school" \[20 U.S.C. 2302\(3\)\]](#), an ["educational service agency" \[20 U.S.C. 2302\(17\)\]](#), an ["Indian Tribe, Tribal organization"](#), or Tribal educational agency or a consortium, [eligible to receive assistance under section 131 of Perkins V \[20 U.S.C. 2351\]](#); or
  - (B) an eligible institution or consortium of eligible institutions [eligible to receive assistance under section 132 of Perkins V \[20 U.S.C. 2352\]](#)
- (2) A state, local, public, or nonprofit entity, e.g., labor and/or workforce board, chamber of commerce, intermediary, or consortium, that partners with one or more eligible recipients, as described in paragraph (1) above, to connect students to high-tech careers aligned with [CHIPS](#).

## Challenge Phases

The CTE CHIPS Challenge will be conducted in three phases. The exact dates of the phases will be determined by the Department and announced on the CTE CHIPS Challenge website.

Phase 1: Registration, Submission, and Selection (5 months)

Phase 1 will include entrants' registration on the [CTE CHIPS Challenge website](#), general technical assistance during the submission period to assist with submission, submission of action plans by entrants, and scoring of eligible submissions.

Up to 50 semi-finalists will be selected to participate in Phase 2 using the criteria outlined in the Phase 1 Selection Criteria section of these Official Rules, Terms, and Conditions.

Phase 2: Incubation, Results, and Selection (12 months)

Phase 2 will include tailored technical assistance conducted by Kaptivate LLC (Kaptivate) while semi-finalists incubate their action plans and actively participate in a community of practice. Phase 2 will culminate with the submission of a result report by each semi-finalist for scoring. Up to 10 finalists will be selected to participate in Phase 3 using the criteria outlined in the Phase 2 Selection Criteria section of these Official Rules, Terms, and Conditions.

### Phase 3: Presentations, Acceleration, Impact, and Prizes (12 months)

At the beginning of Phase 3, finalists will participate in an in-person event in Washington, D.C., to feature the results of their Phase 2 incubation as well as share their Phase 3 acceleration plan. Their acceleration plan will address the following elements: strategic planning, implementation techniques, and applied resources/tools to scale up and sustain project beyond challenge competition. During Phase 3, finalists will receive intensified, tailored technical assistance to assist with their acceleration plan and project sustainability. At the end of Phase 3, each finalist will submit an impact report detailing their accelerated implementation and project impact. Submissions will be scored using the criteria outlined in the Phase 3 Selection Criteria section of these Official Rules, Terms, and Conditions.

### Prizes

The CTE CHIPS Challenge prize pool is \$1,000,000. The cash prizes will be distributed in three tiers based on the Phase 3 Evaluation section of these Official Rules, Terms, and Conditions:

- Tier 1 Finalist (one Grand Prize)
  - \$200,000 cash award (top score)
- Tier 2 Finalists (two Silver Prizes)
  - \$120,000 cash awards (second and third highest scores)
- Tier 3 Finalists (seven Bronze Prizes)
  - \$80,000 cash awards (fourth to tenth scores)

Any potential prizes awarded under the CTE CHIPS Challenge will be paid by electronic funds transfer. The CTE CHIPS Challenge cash prize is not a grant. As such, the cash prize is not awarded with specific terms and conditions like a traditional federal education grant. Award recipients will be responsible for any applicable local, state, and federal taxes and reporting that will be required under applicable tax laws.

### Selection Criteria

#### Phase 1 Selection Criteria

Phase 1 contains four selection criteria, each worth up to 25 points, for a total of 100 points possible per submission:

- (1) **IMPACT.** The extent to which the action plan demonstrates an innovative solution for: (a) increasing students' opportunities and experiences to better prepare them for careers aligned with [CHIPS](#); (b) expanding advising, training, and placement strategies into those careers; and (c) supporting teachers in building out CTE programs.
- (2) **STUDENTS.** The extent to which the proposed activities will involve a broad cross-section of students, including an emphasis on serving students from special populations.
- (3) **PARTNERSHIPS.** The extent to which the action plan includes cross-disciplinary partnerships, written commitments from relevant partners, and at least one CTE program.
- (4) **DATA.** The extent to which the action plan includes baseline project data, and it utilizes quality metrics-framework and data-collection methods.

#### Phase 2 Selection Criteria

Phase 2 contains four selection criteria, each worth up to 25 points, for a total of 100 points possible per submission:

- (1) **IMPACT.** The extent to which the project is: (a) increasing students' opportunities and experiences to better prepare them for careers aligned with [CHIPS](#); (b) expanding advising, training, and placement strategies into those careers; and (c) supporting teachers in building out CTE programs.
- (2) **STUDENTS.** The extent to which the project involves a broad cross-section of students, including an emphasis on serving students from special populations.
- (3) **PARTNERSHIPS.** The extent to which the project includes cross-disciplinary partnerships, written commitments from relevant partners, and at least one CTE program.
- (4) **DATA.** The extent to which the baseline project data has improved, and the metrics-framework and data-collection methods are of high-quality.

### Phase 3 Selection Criteria

Phase 3 contains four selection criteria, each worth up to 25 points, for a total of 100 points possible per submission:

- (1) **IMPACT.** The extent to which the project: (a) increased students' opportunities and experiences to better prepare them for careers aligned with [CHIPS](#); (b) expanded advising, training, and placement strategies into those careers; and (c) supported teachers in building out CTE programs.
- (2) **STUDENTS.** The extent to which the project involved a broad cross-section of students, including an emphasis on serving students from special populations.
- (3) **PARTNERSHIPS.** The extent to which the project included cross-disciplinary partnerships, written commitments from relevant partners, and at least one CTE program.
- (4) **DATA.** The extent to which the project included metrics framework, data collection methods, and comprehensive project data.

## Scoring and Selection Process

### Phase 1 Eligibility Determination Process

The Department, with the assistance and support of Kaptivate, will review Phase 1 submissions to ensure that entrants meet the requirements described in the Eligibility and Submission Requirements sections of these Official Rules, Terms, and Conditions. All eligible submissions will advance to Phase 1 Evaluation.

### Phase 1 Evaluation

Depending on the volume of submissions, an independent review panel may conduct an initial review of eligible submissions against the criteria outlined in the Phase 1 Selection Criteria section of these Official Rules, Terms, and Conditions. A subset of the highest-scoring submissions will then progress for review by independent judging panels.

Subject matter experts will serve as judges to score eligible Phase 1 submissions. Judges will use the Phase 1 Selection Criteria section of these Official Rules, Terms, and Conditions to score the submissions. Judges may assign up to 25 points for each selection criterion for a total of up to 100 points per submission.

The Department will review the recommendations of the Phase 1 judges from the top scoring submissions when selecting up to 50 semi-finalists. The Department may use publicly available data

from the [Education Demographic and Geographic Estimates](#) (EDGE) to consider additional factors to ensure diverse representation.

By participating in the CTE CHIPS Challenge, each entrant acknowledges and agrees that such recommendations of the judges based on the criteria may differ and agrees to be bound by and not to challenge the final decisions of the Department. Scores will not be posted on the [CTE CHIPS Challenge website](#); however, Kaptivate will provide the judges' feedback to entrants who are selected as semi-finalists.

#### Phase 2 Evaluation

Subject matter experts will serve as judges to score Phase 2 submissions. Judges will use the Phase 2 Selection Criteria section of these Official Rules, Terms, and Conditions to score the submissions. Judges may assign up to 25 points for each selection criterion for a total of up to one 100 points per submission.

The Department will review the recommendations of the Phase 2 judges from the top scoring submissions when selecting up to 10 finalists. The Department may use publicly available data from the [Education Demographic and Geographic Estimates](#) (EDGE) to consider additional factors to ensure diverse representation.

By participating in the CTE CHIPS Challenge, each entrant acknowledges and agrees that such recommendations of the judges based on the criteria may differ and agrees to be bound by and not to challenge the final decisions of the Department. Scores will not be posted on the [CTE CHIPS Challenge website](#); however, Kaptivate will provide the judges' feedback to entrants who are selected as finalists.

#### Phase 3 Evaluation

Subject matter experts will serve as judges to score Phase 3 submissions. Judges will use the Phase 3 Selection Criteria section of these Official Rules, Terms, and Conditions to score the submissions. Judges may assign up to 25 points for each selection criterion for a total of up to 100 points per submission.

The Phase 3 submission scores will be ordered numerically, from highest to lowest score, to determine ranking and tier category, as described in the Prizes section of these Official Rules, Terms, and Conditions. In the event of tied scores, the Department will use the selection criteria to break the tie(s) in the following manner:

- The Department will select the submission with the highest score for Criterion 1.
- If that does not break the tie, the Department will select the submission with the highest scores for Criteria 1 and 2.
- If that does not break the tie, the Department will select the submission with the highest scores for Criteria 1, 2, and 3.

The Phase 3 submissions will be ordered numerically, from highest to lowest score, to determine ranking and tier category, as described in the Prizes section of these Official Rules, Terms, and Conditions.

Note: A Phase 3 submission must receive a minimum score of 50 points to be eligible for a cash prize.

# SUBMISSION REQUIREMENTS

To participate in the CTE CHIPS Challenge, an entrant must be eligible according to the Eligibility section of these Official Rules, Terms, and Conditions and complete the entry requirements outlined in the Submission Requirements section these Official Rules, Terms, and Conditions.

## Challenge Website

All submissions will be processed using the official [CTE CHIPS Challenge website](#). Submission requirements include the following elements:

- (a) Register on the [CTE CHIPS Challenge website](#);
- (b) Enter a submission on the [CTE CHIPS Challenge website](#) according to these Official Rules, Terms, and Conditions and submission form requirements;
- (c) Comply with all requirements on the [CTE CHIPS Challenge website](#);
- (d) Acknowledge limit of one winner per eligible recipient;
- (e) Self-select eligibility category—that is bullet (1) or (2) provided in the Eligibility section of these Official Rules, Terms, and Conditions;
- (f) Affirm the entrant’s administrator(s) permit(s) entry into the CTE CHIPS Challenge; and
- (g) Agree to:
  - (1) Assume any and all risks and waive claims against the Federal government and its related entities, except in the case of willful misconduct, for any injury, death, damage, or loss of property, revenue, or profits; whether direct, indirect, or consequential, arising from their participation in the Challenge; whether the injury, death, damage, or loss of property, revenue, or profits; whether direct, indirect, or consequential, arises through negligence or otherwise;
  - (2) Indemnify the Federal government against third-party claims for damages arising from, or related to, Challenge activities, patents, copyrights, and trademark infringements; and
  - (3) Comply with and abide by these Official Rules, Terms, and Conditions and the decisions of the Department which shall be final and binding in all respects.

## Submission Dates, Times, and Requirements

The CTE CHIPS Challenge officially begins on the start date with this announcement and continues until the submission deadline.

Challenge.Gov and Kaptivate are the official timekeeper for the CTE CHIPS Challenge. Submissions must be received by the submission deadline to be eligible for review. To submit an entry, an entrant must go to the [CTE CHIPS Challenge website](#) and complete all required fields of the submission form before the submission deadline. Each entrant must complete all of the required fields in the submission in accordance with these Official Rules, Terms, and Conditions. All entrants are required to provide

consent to these Official Rules, Terms, and Conditions upon submitting an entry. The Department reserves the right to disqualify any submission that the Department deems inappropriate.

Entrants must designate a primary contact to serve as the project lead. Each project lead must be employed as a CTE teacher, coordinator, or administrator by the eligible recipient or be employed by the state, local, public, or nonprofit entity, e.g., labor and/or workforce board, chamber of commerce, intermediary, or consortium partnering with the eligible recipient; and they must be at least 18 years of age. A school may collaborate with another school or schools; however, one project lead and lead school must be identified. In the event that a dispute regarding the identity of the entrant who actually submitted the submission cannot be resolved by the Department, the affected entry will be deemed ineligible.

### Technical Problems, Submission Extensions, and Accommodations

The Department encourages entrants to submit entries as far in advance of the submission deadline as possible and suggests at least two hours before the submission deadline to ensure the completed submission is received. If an entrant submits an entry after the submission deadline because of a technical problem with the [CTE CHIPS Challenge website](#), the entrant must immediately contact the individual listed in the Contact Information of these Official Rules, Terms, and Conditions, and they must provide an explanation of the technical problem experienced on the [CTE CHIPS Challenge website](#). The Department will accept the entrant's submission if the Department can confirm that a technical problem occurred with the [CTE CHIPS Challenge website](#) and that the technical problem affected the entrant's ability to submit an entry by the submission deadline. The Department will contact the entrant after a determination is made on whether the entry will be accepted.

Submission extensions only apply to the unavailability of, or technical problems with, the [CTE CHIPS Challenge website](#). The Department will not grant an entrant an extension in the event of user error; for example, if the entrant failed to submit an entry on the [CTE CHIPS Challenge website](#) by the submission deadline, or if the technical problem experienced is unrelated to the [CTE CHIPS Challenge website](#).

Individuals with disabilities who need an accommodation or auxiliary aid in connection with the submission process should contact the individual listed in the Contact Information section of these Official Rules, Terms, and Conditions. If the Department provides an accommodation or auxiliary aid to an individual with a disability in connection with the submission process, the entry remains subject to all other requirements and limitations in these Official Rules, Terms, and Conditions.

## ADMINISTRATIVE INFORMATION

### Program Authority

The purpose, call to action, and activities related to the CTE CHIPS Challenge are authorized by the *Carl D. Perkins Career and Technical Education Act of 2006* ([Perkins V](#)). Under [section 114\(c\)\(1\) of Perkins V, 20 U.S.C. 2324\(c\)\(1\)](#), the Secretary of Education is authorized to carry out research, development, dissemination, evaluation and assessment, capacity building, and technical assistance regarding CTE programs under the Act. The CTE CHIPS Challenge will result in a public collection of resources for the benefit of Perkins-funded CTE programs.



## Definitions

The definitions of “CTE”, “eligible recipient” and “special populations” are from section 3 of the Carl D. Perkins Career and Technical Education Act of 2006, ([20 U.S.C. 2302](#)) ([Perkins V](#)).

## Contractor Support

The CTE CHIPS Challenge is an open innovation prize competition conducted by the Department. The Department has contracted Kaptivate, LLC (Kaptivate) to assist and support the Department in organizing and managing the CTE CHIPS Challenge.

## APPENDIX A: CONTEXTUAL BACKGROUND

The purpose of [Perkins V](#) is to “develop more fully the academic knowledge and technical and employability skills of secondary education students and postsecondary education students who elect to enroll in CTE programs and programs of study” [20 U.S.C. 2301](#). CTE is an essential strategy for developing a more competitive workforce and preparing students to succeed in careers. Evidence-based components of CTE, within career-connected high schools, include dual enrollment, work-based learning, workforce credentials, and career advising and navigation. Emerging technology is a critical aspect in an increasing number of jobs, and education providers and institutions must adapt to prepare students for cutting-edge, high-quality careers that will continue to build our nation’s future. Growth industries, including semiconductors, clean energy, aerospace, robotics, medicine, technology, and sustainable development all point to an increasing need for applied technical learning.

Outside the education setting, the Biden Administration’s [Investing in America](#) agenda supports workforce development strategies to address education and training in semiconductors, clean energy manufacturing, batteries and electric vehicles, biomanufacturing, heavy industry, and more. The U.S. semiconductor industry contributes more than \$246 billion to the U.S. economy, employs more than 277,000 workers, and reaches well beyond fabrication (fabs) or research facilities. It includes semiconductor fabrication packaging, design services, testing labs, and research development (R&D) activity. As a national report recently concluded, “this ecosystem creates activities that generate additional economic value throughout the U.S. economy.”<sup>iii</sup> These growth industries provide robust pipelines for workforce development and require skilled workers.<sup>iv</sup> Hence, the nation is making strategic investments “to keep the United States the leader in the industries of tomorrow.”<sup>v</sup>

It will be important for education providers and institutions to prepare students for these cutting-edge careers that will continue to build our nation’s future, and for CTE programs to accelerate student recruitment, training, and placement in these industries. By leveraging the power of CTE, the CTE CHIPS Challenge will reward plans to provide students with increased opportunities to develop skills and experiences that better prepare them for careers that align with [CHIPS](#). The CTE CHIPS Challenge seeks to play a part in supporting the Investing in America agenda that includes:

(a) Bipartisan Infrastructure Law ([BIL](#))—2021

[BIL](#), also referred to as the [Infrastructure Investment and Jobs Act \(IIJA\)](#)<sup>vi</sup> ensures employers have access to a diverse and equitable pool of skilled workers.<sup>vii</sup> For example, [BIL](#) provides funding to support half-a-million electric vehicle chargers; prioritizes \$7 billion to amplify EV battery production; and sponsors \$10 billion for clean transit and school buses.<sup>viii</sup>

This program may be subject to the Build America, Buy America Act (Pub. L. 117-58) domestic content procurement preference requirements and to the corresponding guidance in 2 CFR Part 184. Additional information regarding Investing in America is available on [Invest.gov](#); the website includes a detailed map of major projects in all 50 states.

(b) [Inflation Reduction Act \(IRA\)](#) – 2022

[IRA](#) marks the most significant action Congress has taken on clean energy and manufacturing by investing in domestic energy production.<sup>ix</sup>

(c) [CHIPS and Science Act \(CHIPS\)](#) – 2022

[CHIPS](#) invests billions of dollars to expand America’s manufacturing capacity of semiconductors, including research, workforce development, incentives, tax credits, and broaden global competitiveness.<sup>x</sup>

(d) Raise the Bar: Lead the World – 2023

The U.S. Department of Education’s initiative [Raise the Bar: Lead the World](#)<sup>xi</sup> supports a national call to action to “establish and scale career and college pathways that lead to students earning industry-recognized credentials and securing in-demand jobs.”<sup>xii</sup> Further information regarding building capacity among secondary education, postsecondary education, and workforce development systems to expand access to career-connected high school programs for more students is available on the [Raise the Bar: Unlocking Career Success website](#).

## Representations and Warranties/Indemnification

By participating in the CTE CHIPS Challenge, each entrant represents, warrants, and covenants as follows:

- (i) The entrants are the sole authors, creators, and owners of the submission;
- (ii) The entrant's submission:
  - (a) Is not the subject of any actual or threatened litigation or claim;
  - (b) Does not, and will not, violate or infringe upon the privacy rights, publicity rights, or other legal rights of any third party;
  - (c) Does not contain any harmful computer code (sometimes referred to as "malware," "viruses," or "worms"); and
- (iii) The submission, and entrants' implementation of the submission, does not, and will not, violate any applicable laws or regulations of the United States.

Entrants will indemnify, defend, and hold harmless the Department and Kaptivate from and against all third-party claims, actions, or proceedings of any kind and from any and all damages, liabilities, costs, and expenses relating to, or arising from, entrant's submission or any breach or alleged breach of any of the representations, warranties, and covenants of entrant hereunder.

The Department reserves the right to disqualify any submission that the Department, in its discretion, deems to violate these Official Rules, Terms, and Conditions.

## Submission License

Each entrant retains title to, and full ownership of, their submission. The entrant expressly reserves all legal rights not expressly granted under this agreement. By participating in the CTE CHIPS Challenge, each entrant hereby irrevocably grants a license to the Department and Kaptivate to store and access submissions in perpetuity that may be reproduced, published, or distributed in the future. ## Publicity Release

By participating in the CTE CHIPS Challenge, each entrant hereby irrevocably grants to the Department and Kaptivate the right to use such entrant's name, likeness, image, and biographical information in any and all media for advertising and promotional purposes relating to the CTE CHIPS Challenge in perpetuity and otherwise as stated in the Submission License section of these Official Rules, Terms, and Conditions.

## Disqualification
